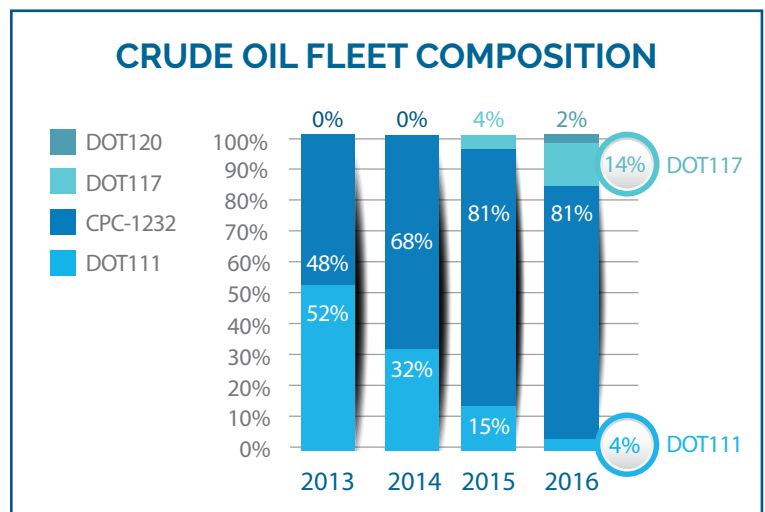

As of June 2016, more than 97 percent of DOT-111 cars had been removed from service, 18 months ahead of the 2018 deadline.

All tank cars operating in crude and ethanol service are in compliance with current regulations.

RSICTC members anticipate that they will be able to meet all future deadlines for the modification of existing cars and production of new cars to the DOT117 standard.

## BACKGROUND

Over the past four decades, the Railway Supply Institute's Committee on Tank Cars (RSICTC) has been a leader in advancing design and safety of rail tank cars. During the last five years, the Committee led advocacy efforts for new DOT regulation, HM-251, and pushed Congress to pass the FAST Act, which overhauled the standards for tank cars in crude and ethanol service.

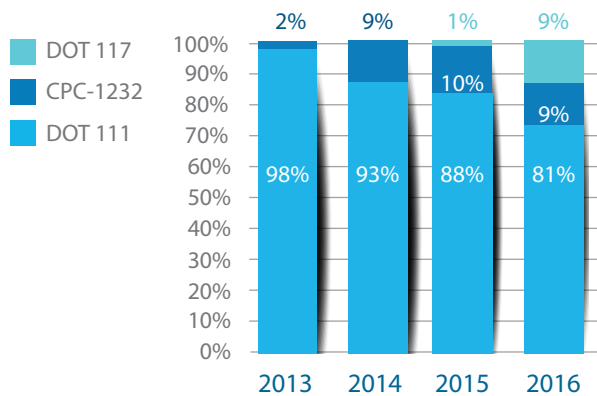
## ABOUT

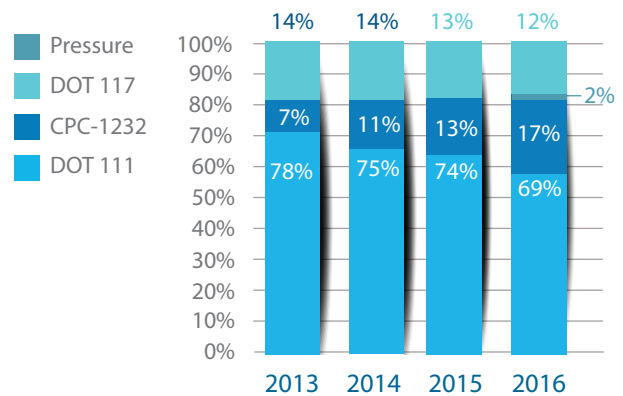
ETHANOL FLEET COMPOSITION

# MODIFICATION TIMELINE

For many years, RSCITC and its members have been actively working to develop recommendations, advocate for, and ensure efficient implementation of new standards for tank cars, including the HM-251 standard and the 2015 FAST Act. In 2015, Congress set the following deadlines for the modification of the rail tank car fleet.
